Hausordnung - Schakelvilla – Langezand 33 – 8754 HR Makkum

On your Arrival:

When you arrive, check for any apparent damage in or around the house and that everything is in working order. Please inform us immediately of any damage that you find and do not attempt to repair yourself.

General:

The tenants are asked to show consideration to the house and park "Makkumer Strand" rules (see below). We do our best to keep all indoor and outdoor facilities in a working and safe condition, but using the outdoor facilities and equipment is at your own risk. In the interests of good relations with the other tenants and owners in the Beach Resort, we ask that you avoid excessive noise (eg partying on the terrace), before 8 a.m. and after 11 pm volume should be kept to an appropriate level.

Bathroom:

To avoid build-up of limescale deposits on shower glass and tile walls, we ask that you wipe down the tiles etc. with the provided squeegee, also please leave the bathroom door open for ventilation. Do not flush hygiene products, sanitary towels, rubbish, leftover food, etc. in the shower or toilet, to avoid blockage or bad smells.

The first-floor toilet occasionally continues to run after it has been flushed. Please ensure this does not happen by pressing the flusher again to stop the water flow.

Damage:

It is inevitable that occasionally accidental damage happens. We ask you to inform us immediately so that repairs can be arranged as quickly as possible. Please do not wait to inform us after your holiday, as the next tenants have the right to a damage free property. Damage caused by the tenant or their guests will be charged according to the replacement and installation value - of course, small items such as a broken cup are excluded.

Please do not leave seat cushions in the rain or outside overnight. Should the seat cushions accidentally become damp, separate, and allow to dry to avoid mould - also for the next tenant.

Should it rain or in strong winds, retract the awning and close any opened sunshade(s). On the west terrace (street side) please tie down the parasol with the existing rope. On the south terrace (garden side) put the protective cover over the parasol (this is best done with two people if the parasol is tilted slightly).

Being close to the sea, sudden changes in weather can often occur. If you leave the house, take precautions as stated above.

In the evening, or in strong winds, the garden furniture is to be stowed and secured with the existing rubber ropes. The garden furniture on the west terrace (street side) must also be placed against the house wall and secured with a rubber rope.

To avoid damage when open, the patio doors must always be used with the safety hooks on the outside house wall.

The gas grill is to be covered and secured with the brakes on the right front side of the south-facing terrace.

The awning must not be extended in strong winds or rain/drizzle.

Indoor furniture may not be used outdoors.

Electric car / plug-in hybrid

The nearest charging point for your e-car or plug-in hybrid can be found directly in the parking lot at the entrance to the holiday park. There is currently no charging facility at our holiday home. Charging at our house is not permitted and the electricity for this is not included in the rental price. Driving on the meadow and the sidewalk for charging via the household power socket is not permitted. Damage to the lawn and sidewalk as well as increased power consumption due to charging an e-car or plug-in hybrid will be deducted from the deposit and/or charged for.

For the future we are planning to install a wall box to enable direct charging at our holiday home.

Outdoor Lightning:

There are three lamps next to the respective doors (west terrace, entrance and south terrace) on the house. The light switches for these are located directly inside the respective doors.

There are four more patio lights from Philips Hue on the terraces. You can use the remote control (inside to the left of the patio door on the south-facing terrace) to switch them on, off, and dim, as well as selecting different colours by pressing the "switch". Please note that the remote control is only attached magnetically to the bracket and can fall if you are not careful.

The lamps in the flower beds and flowerpots are solar powered so will turn on at dusk.

We ask that the terrace lighting is switched off during the day.

BBQ's:

Gas BBQ

Our gas grill is available to you for the duration of your stay.

For the operation:-

We have two gas bottles available, one connected to the grill under the grilling plate the other full bottle is in the utility room. If you run out of gas while grilling, you always have a spare bottle at your disposal. You can easily change the gas bottle on the back of the grill by turning the gas line from the bottle (on the large nut). Usually it is removeable by hand, but if something should get stuck, we have pliers in the grill cart that can be used.

The cost to use the gas is at your own expense and we ask that you refill the bottle from:

The Spar supermarket at the pyramid of the campsite "de holle poarte". To do this, simply take the empty bottle to the Spar supermarket and ask for a replacement bottle to the right of the bread counter (exchange bottle Cost 18.95€).

In the winter season, the Spar Market is closed, please use the local hardware store "Karwei in Bolsward or Sneek " directly off the motorway (exchange bottle Cost 22.50€)

A 50€ charge will be withheld from your deposit for any empty gas bottle left after your holiday. We would appreciate it if you informed us of replaced gas bottles.

Before you use the grill, please put aluminium foil on the grease drip tray, the foil can be found under the sink in the kitchen. Remember to put a small hole in the middle to allow the fat to run into the fat catcher.

The grill must be left clean after use, a wire brush hanging on the grill cart and the scraper hanging next to it can be used to do this. Do not clean the grill racks in the Dishwasher.

The surfaces of the grill should be wiped down with a cloth or paper towel after use. Unfortunately, some grease may drip inside the cart, please remove this with a cloth or the paper towel. p

After grilling, the protective hood must be placed over the grill and fastened with the cord so that the hood is secured against the wind. See picture below.



Coal Grill

If you prefer to grill with coal, you are welcome to use the coal grill that is at the front of the house - west terrace. There is a wire brush on the grill for cleaning.

Please grill at least half a meter from the house and clean the grill after use with the wire brush and cloth or paper towels.

General use:

Of course, you are free to move the grills to either terrace during your holiday, but please ensure that no grease drips onto the paving, that you leave the grills clean and that you returned the grills to correct location. Dirty grills or stains left after your holiday will be cleaned at your expense.

The use of the grill is at your own risk.

Pets:

If you would like to go on holiday at the IJsselmeer with your dog, this is also possible in our house. However, we would like to ask you not to take your pet with you on the sofa or to bed. A leash is compulsory in the holiday park and on the beach. Unfortunately, dogs are not allowed on the beach in summer. The large outdoor area opposite the entrance to the holiday park is a suitable alternative. Please pick up the dog waste and dispose of it in the respective rubbish bins, which are set up throughout the holiday park and usually also have dog waste bags available free of charge.

Kitchen:

Do not place hot pots, pans or other hot appliances on the Kitchen top or tables without coasters. Please ensure that the dishes, all kitchen utensils, pots, airfryer, oven etc. are left in a clean and orderly condition when you leave.

Instructions on how to use devices can be found in the living room cabinet drawer. If something is still unclear, please feel free to contact us.

Additional costs:

The rental price includes normal use of electricity, gas, water, washing machine, dryer, sauna, WiFi and garbage. Please avoid unnecessary consumption (eg doors and windows open with the heating running or sauna continuously heating without use).

Our rental price is calculated based on normal consumption; we reserve the right to request a subsequent charge should you use the utilities excessively.

Smoking:

Our holiday home is strictly NO-SMOKING. Smokers that rent the home agree to only smoke outside. Cigarette ashes and butts are to be collected in an ashtray (located in the living room cupboard). The ashtray must be cleaned and returned to the living room cupboard on departure.

Should you or your guests not follow the guidelines a charge will be applied for basic cleaning and any damages such as holes or burn marks on furnishings, floors, upholstery, etc.

Rubbish:

A central waste collection point for rubbish, paper and glass is located at the reception building just before the barriers at the exit. Please deposit your waste here throughout your holiday and especially when you leave.

Cleaning:

The cleaning of the house is the responsibility of the tenant during the rental period. The final cleaning is carried out by us. On departure, the house should be left swept, dishes cleaned and in the designated cupboards and rubbish bins emptied (more under "Departure").

Rowboat:

The rowing boat "Turbo Smurf" is included in the rental price. The two oar pins and plug can be found on the House key hooks by the front door and the two oars are in the sauna room to the right. The Turbo Smurf rests to the left of the Jetty and is tied to the wharf with a rope.

When using the boat, please note the following:-

It is a rowing boat; the use of an engine is NOT permitted. In the evening, the boat must be pulled out of the water and attached to the front jetty. On departure oar pins, oars, stopper, and boat must be left as it was found.

Shoes:

We ask that you remove your shoes when in the house and avoid walking through the house with dirty or wet shoes.

Play equipment:

Behind the house is a play tower with a slide and a trampoline. For younger guests there is a buggy, balance bike and a bobby car found in the Utility room. We endeavour to keep all play equipment intact, however the use of these items is at your own risk and without guarantee. If you notice any damage, please advise us.

Jetty:

You are welcome to use our jetty for sunbathing, fishing, and swimming as well as a boat dock. Depending on the weather, the jetty and the ladder can be slippery. When swimming, please take care with the jetty ladder as the lower steps with no rubber protection can scratch.

Surfboard:

The surfboard, which is in front of the house against the building, must be attached to the jetty or posts on the lawn when not in use, when absent or at night please stow safely but do not put the surfboard on the fin. Return the surfboard before departure.

Washing machine and dryer:

A washing machine and dryer are available in the utility room. Please clean the fluff filter after each use of the dryer. If you require help on how to use feel free to call.

Winter service:

The access road, pathway to our house and on our property is not swept or cleared in winter. So please be particularly careful in cold weather that you do not slip. A broom is available to clear snow, please do not sprinkle salt. In very bad weather it is advised to park your car at reception so that you are not block in.

WLAN:

The Wi-Fi LAN in the house is called "Schakelvilla.de" it is available free of charge. The Wi-Fi password is "Langezand33" we ask that you do not pass on the password to third parties who are not tenants or guests. We cannot guarantee 100% availability of the Wi-Fi in the event of issues with the provider. The data traffic using the Wi-Fi is unencrypted with no virus protection or firewall. The Wi-Fi may not be used to access or distribute immoral or illegal content. The tenant is liable if prosecuted by third parties or for violations of any kind.

Departure:

On the day of departure, please leave the house cleared and swept by 10:00 a.m. at the latest. Before leaving, please ensure that you have - washed and put away the dishes, emptied the rubbish bins and set the thermostat heating in the living room to 15 degrees Celsius. Also leave the dishwasher door slightly open and close all windows. Plus disconnect the electrical appliances in the kitchen (coffee maker/kettle/toaster etc.) from the electricity.

Please wipe down the inside and outside of the refrigerator and set the temperature to the "warmest setting".

Hang the parking card on the house key hook and lock the house key back in the key safe next to the entrance. If you have used the second parking card needed to launch a boat into the water via the slipway, please return to the very back of the folder with the boat on in the living room cupboard. All cards unaccounted for at the end of your stay will be replaced at your own cost with charge. of 15€

We ask you to return the cushions from the outdoor furniture including seat cushions to the storage box and lock with the padlock provided. The small play equipment (bucket, shovel, etc.) needs to be put into the other box next to the front door and locked with the padlock provided.

The BobbyCar, the children's balance bike, the children's buggy and the loungers are to be returned to the utility room.

The seating furniture on the west terrace (street side) should be secured around the table with the existing rubber rope and placed in front of the corner of the house (surfboard/kitchen window).



On the south terrace (garden side) the seating furniture must also be secured around the table with the existing rubber rope and the grills are to be cleaned after use as described above.

In the case of a gas grill, the fat must also be removed from the fat drip tray and the tray cleaned. The funnel-shaped fat collecting tray is to be pulled out from the back of the grill, the previously attached aluminium foil is to be removed and any dirt from the tray removed with the scraper. Please add a new aluminium foil and remember to make a hole in the middle of the fat outlet. Fat that has dripped onto the bottom of the trolley needs to be removed.

Please also leave the charcoal grill cleaned and without ash residues (you can easily remove these by pulling out the silver sheet below). When you leave, return the grill to the wall between the kitchen window and the door to the utility room, as seen in picture above.

Retract the awning and close the open parasol(s). Please tie the parasol on the west terrace (street side) with the existing rope and put the existing protective cover over the parasol on the south terrace (garden side).

Make sure that the outside lighting is switched off when you leave and that there is no water running in the house (especially not the ground floor toilet).

Should you partially or not at all carry out the activities listed above, we reserve the right to withhold all or part of your deposit to cover the additional expense incurred by our cleaning company or any resulting weather-related damage.

Park regulations of a holiday home in the Villapark "Makkumer Strand"

1. We ask you to show consideration for other guests who, like you, have come here to relax and enjoy your holiday.
2. Each holiday home has its own property with a jetty. It is generally not permitted to enter the property or a jetty of another holiday property.
3. We ask you not to use the property as a football or volleyball field. In the Holiday Park there is sufficient suitable space on the leisure fields and on the beach.
4. It is not permitted to dig holes, hollows, or the like on the property due to existing cables, lines and other facilities in the ground.
5. Please keep the area, the building, the plants, and the garden clean and do not damage anything.
6. The pitching of tents and the parking of caravans or mobile homes is not permitted.
7. The wilful causing of noise pollution is prohibited.
8. Between 11 p.m. and 8 a.m. there is quiet time in the park, eg, no music, no running engines or other motorized trips.
9. Open fires in the park are prohibited. Watch out for fire hazard.
10. Barbecuing is permitted at our holiday home, simply use one of our two grills or your own grill. In the vicinity of houses with thatched roofs, barbecuing is only permitted with electric or gas-powered barbecues at a sufficient distance from the house. It is forbidden to light fireworks in the holiday park.
11. It is not permitted to dry laundry on rotary clothes dryers and clotheslines. We have a tumble dryer and two drying racks for drying clothes outside.
12. The maximum speed in the entire Holiday Park is 15 km/h.
13. Please park your car(s) on the parking lot in front of the house. The house has two parking spaces in front of the house. It is not allowed to park your car outside of these places.
14. The maximum speed on the water in the holiday park is 5 km/h. This also applies to the water after the drawbridge. In addition, the legal rules for water traffic of the Dutch Office for Water Management and Public Works (Rijkswaterstaat) apply. You must be at least 12 years old to drive a small motorboat. To drive a motorboat at more than 20 km/h, you must have a corresponding (boat) driver's license and be at least 18 years old. At the same time, the other statutory provisions also apply eg on your boat there must be, a fire extinguisher, life jackets, registration with the CBR (Dutch Central Office for Driving Licenses), insurance and the driving almanack Part 1 must be present. In this regard, the Dutch water police as well as the Rijkswaterstaat and customs conduct regular checks. These controls take place both inside and outside the holiday park. Violations are severely punished. Please also ensure that you do not cause any damage to the banks or the plantings. We have summarized further information on water transport here.
15. If you want to fish on the park area, you must have the appropriate permit (fishing license). This is available in the fishing shop in Makkum. You can find more information about fishing and fishing on our website under - IJsselmeer - Fishing.
16. Our holiday home can only be inhabited by the number of people for whom you have booked. If you have visitors, please let us know. If your guests also stay overnight with you, a surcharge must be paid (visitor's tax).
17. It is not permitted to bring furniture, beds, blankets etc. outside.
18. We expect that you leave our holiday home in good condition on departure. This means that you leave the holiday home swept clean, do not leave dirty dishes, and empty the dishwasher and dispose of your waste in the appropriate containers at the holiday park (waste separation paper, glass, and other waste). Please do not switch off the refrigerators and keep their doors closed.

In the event of a breach of the parking regulations (or a disregard of the house rules, our instructions, the management, their employee's instruction or damage to the property), we are entitled to offset this against your deposit and in serious cases to expel you immediately from the park. If the deposited deposit is not enough to cover the damage, we are unfortunately forced to hold our guests liable.

The house service checks the condition of the holiday home before your arrival and after your departure. Please report any damage to us immediately so that it can be fixed as quickly as possible.
